

Terms of use "Mijn Hoofbosch"

Read this information carefully before you continue to use "My Hoofbosch".

General

The content of all web pages of investment fund Hoofbosch (the "Website" and the "Platform") has been compiled by De Grote Voskuil Capital BV (hereinafter "Hoofbosch"), with its registered office in Haarlem, address Nieuwe Gracht 23 in Haarlem. Hoofbosch acts as manager of investment institutions within the meaning of Section 1: 1 of the Wft. Hoofbosch is supervised by the AFM and DNB, whereby the AFM granted a license on 19 July 2013 on the basis of Section 2:65 (1) (a) of the Wft.

Safety

Hoofbosch attaches great importance to the security of your data. With our Platform ("My Hoofbosch") we offer you a safe environment with very strict security measures, provided you follow our advice for safe use. Below you can read what Hoofbosch is doing to make the Platform as safe as possible and what you need to do yourself.

Ensure proper protection of your own internet environment

- Use a computer with an up-to-date browser and operating system and install all updates;
- Ensure a good virus and malware scanner, firewall and anti-spyware and install all updates;
- Do not use public Wi-Fi hotspots to use the Hoofbosch Platform;
- Do not install illegal and / or unknown software;
- Check the URL and lock of the secure connection when you log in to the Platform of Hoofbosch. The URL must begin with https instead of http. You can see the padlock in the address bar or at the bottom right of your browser;
- Log out as soon as you are ready;
- Always keep your password secret. Employees of Hoofbosch will never ask for your password, neither on the phone nor by e-mail;

Your "My Hoofbosch" account

E-mail address

When creating an account on the Platform of Hoofbosch you have entered your e-mail address. We have verified this email address with you. If you wish to change your e-mail address via the Platform, we will also verify your new e-mail address.

Your username

When creating access to the Platform of Hoofbosch, you create a user name yourself. This username is unique.

Choose password

When creating access to the Platform of Hoofbosch, you determine your password yourself. For security reasons you will not receive a password by physical mail. Your password must

meet some requirements, so that others cannot (easily) retrieve and / or guess your password. We advise you to change your password regularly (at least every six months).

change Password

If you have forgotten your password, you can choose a new password by clicking on the 'forgot password' link in the login screen. For your safety, you will then receive a link via e-mail to a screen where you can create a new password. Your password is your personal property, employees of Hoofbosch do not have access to your password!

E-mail notification

Every time a change or transaction takes place on your account, you will receive a notification from Hoofbosch via e-mail (sender: noreply @ mijn hoofbosch.nl). For your own safety, you will not see in the e-mail exactly what the transaction was. On "My Hoofbosch" you can view all transactions on your account. You will also receive a confirmation by e-mail of all changes to your personal data or contra accounts.

Please note: Hoofbosch never asks you for your login details by telephone or e-mail. You are always first referred to [https:// my Hoofbosch.nl](https://my.Hoofbosch.nl).

The secure environment

You can give assignments through the secure environment of our Platform "My Hoofbosch". This is only open to participants and requires that you log in with your username and password. Outsiders cannot access the details of our participants.

Every time you log in to "My Hoofbosch" a secure connection is established. Data is sent encrypted. You can recognize this connection by the padlock in the address bar or bottom right in your browser. You will also see that the address at the top of your browser starts with 'https' instead of 'http'. All Hoofbosch systems are in secure environments at different locations.

Time of last login

If you are logged in, you will see at the top right when you were last logged in.

Only transfer to your own contra account

From your account is only money transferred to the previously provided by you and by Hoofbosch verified against account. This contra account must be in the same name as your account. The transferred amount can only end up with you.

Changing a contra account can only be done by making a request via a form made available on the Platform. You fill in this form, provide your signature and identify yourself by means of a signed copy of a valid proof of identity and a copy of a daily statement of the new contra account, which we will check upon receipt.

Checking outgoing amounts

Hoofbosch checks all outgoing amounts and checks them for unusual patterns. In the event of a suspicious transaction, the payment will be blocked and verified by telephone. That is why we need a telephone number from which you can be easily reached.

Be careful !

Hoofbosch is very alert to signals from our participants. In the event of a potential risk, Hoofbosch can quickly block all its systems. Hoofbosch therefore expects you to respond alertly to suspicious cases and to pass them on directly to us by telephone or e-mail.

Geographical limitations

Hoofbosch mainly offers its investments in the Netherlands. The information on the Platform is not intended for visitors from countries where the offering of Dutch financial services is not permitted, or where the services of Hoofbosch are not available.

Please note: as a visitor to the Platform, you are responsible for compliance with the laws and regulations applicable in your country.

The information provided on the Platform is not investment advice or a financial service. You can and may only base a decision to invest in Hoofbosch on the information from a valid prospectus, the Key Investor Information Document and other information about the relevant investment (such as (semi) annual reports). This information is available on the Platform and the Website.
