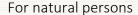

DOCUMENTS, DEPOSIT, RATE OF ISSUE AND COSTS TO BE SENT ALONG

Documents to be sent along

In the context of the Money Laundering and Terrorist Financing Prevention Act (the "Wwft"), the following documents must be sent with the registration:

- I. a copy of the participant's identity card(s) (passport, (European) driving license or Dutch identity card (Note: a copy of the front and back is required for identity card and driving license!)).
- II. a copy of a bank statement showing the name and address of the participant(s).

Deposit

The amount must be credited to the following bank account no later than the last business day before the start of the month:

The amount deposited must come from a bank account in the name of the participant, held at a bank established in a Member State as described in the Wwft. In that case, the amount deposited by the participant into the bank account of the Legal Owner will be immediately refunded to the account from which the amount was received.

Price of issue

In accordance with the Prospectus, the allocation of participations at the net asset value of a participation takes place on the first possible day of admission after the day on which the amount stated on the subscription form is received by the Legal Owner.

Admission takes place with a deduction of 0.5% entry costs.
